She got Covid 19, and she asked for the reward in the end. Then Jayalath refused to pay her Rs 100,000 and stated that there was no contract between Gaya and him and they had published the advertisement only for sales promotion purposes. Can Gaya claim the reward?

Russell's insurance company refused to honour Russell's claim for the damages of the boat, saying that Russell did not own it at the time of the accident. Did Russell have title to the boat at the time of the accident? Describe your answer referring to Sale of Goods law.
